Shabach Services LLC has partnered with companies who have Sales force teams that are able to deliver products in a very timely manner and act as a service provider. We work very closely with these companies, taking ownership on ordered medical supplies. The expected days of delivery is usually between 2- 10 business days and should products be on b/o, this is communicated to the user in a timely fashion. We always strive to also offer alternatives to our end users after much research. Shabach Services has a presence in all States and there are no limitations.

Marketing Plan

Should Shabach Services be awarded a contract, we intend to first understand the requirements of the end user, in terms of time lines and all expectations. The mode of communication would either by phone or email, however we always strongly encourage orders to be sent via email by way of a Purchase Order (PO). The Contracting Officer (CO) or end user (EU) is encouraged to send an email to Shabach Services via email requesting price. The price is sent back approximately 1 business day to the user. Once the price has been agreed upon by the EU, a PO is issued and sent to Shabach Services via email (shabachservices@gmail.com). Upon receipt of the PO, if after 3pm, the order will be placed the next business day and if before 3pm, it will be placed the same day. Once shipment and Tracking information has been received, this will be communicated via email to the contracting officer who issued the PO. Very seldom do we verbally communicate unless it's an issue that requires such communication. *A list of some of the Medical Supplies we provide is also attached as a part of this correspondence*. As a growing small business, our products are currently not available through an e-procurement ordering process
